

**Application Guidelines for  
Admission to  
Graduate Schools of Yokohama National University as Doctoral  
Students under the Chinese Government Graduate Student Overseas  
Study Program (Admission in October 2017 and in April 2018)**

Yokohama National University is recruiting students who want to enter its graduate schools as doctoral students in October 2017 or April 2018 under the Chinese Government Graduate Student Overseas Study Program.

**1. Graduate Schools and Programs Recruiting Students and Quota for Admission**

\*All-in-English Programs of the Department of Economics and the Department of International Business Law do not admit students under the Chinese Government Graduate Student Overseas Study Program as they currently recruit students through different admission procedures.

**2. Application Eligibility**

To be eligible, you must have Chinese citizenship and be eligible to apply for the Chinese Government Graduate Student Overseas Study Program set by the China Scholarship Council (CSC) as well as meet all the following requirements:

- (1) You have completed a master's program and earned a master's degree or are expected to have completed a master's program and earned a master's degree at any of the universities listed in the appendix before your admission to Yokohama National University.
- (2) You intend to earn a doctoral degree within 48 months of your admission to Yokohama National University as a doctoral student.
- (3) You have asked the supervisor of your choice about research details, acceptance conditions and the like, and have obtained permission to apply before making an application.
- (4) You are proficient in Japanese at a level equivalent to or higher than N2 of the Japanese-Language Proficiency Test (or Level 2 under the former testing system) if you want to receive research guidance in Japanese. Or you are proficient in English at a level equivalent to or higher than a score of 80 in TOEFL iBT or an overall band score of 6.0 in IELTS if you want to receive research guidance in English.

### 3. Application Documents

You must prepare all application documents in Japanese or English. For any language other than Japanese and English, you must attach its Japanese or English translation bearing an official seal to every certificate.

- (1) Information Sheet ([Use the attached form.](#))
- (2) Application form and curriculum vitae ([Use the attached form.](#))
- (3) Field of Study and Research Plan ([Use the attached form.](#))
- (4) Recommendation letter from the department head of your university or your supervisor at your university (Submit the original.)
- (5) Certificate of (expected) completion of master's degree issued by your university (Submit the original.)
- (6) Academic transcript of master's program issued by your university (Submit the original.)
- (7) Master's thesis (If it is written in Chinese, submit its Japanese or English abstract, too. If you are unable to submit your master's thesis, you can submit any thesis you plan to submit or an abstract of such a thesis.)
- (8) Score report(s) for a Japanese and/or English language proficiency test (such as Japanese-Language Proficiency Test, TOEFL, and IELTS)
- (9) Two photographs of yourself (40 mm long by 30 mm wide) (Attach one of them to the application form.)
- (10) Published books and papers, reports and conference presentations that demonstrate your achievement and ability. (If any. Attach a list. If it is written in Chinese, submit its Japanese or English abstract, too.)

### 4. Application Procedures

#### (1) Before Applying

Before applying, you must ask the supervisor of your choice about research details, acceptance conditions and the like, and obtain his/her permission to apply. You can find a supervisor in the "List of Professors for International Students" (<http://www.ynu.ac.jp/english/exam/professors.html>) on our website. When you send an email concerning permission to apply to the supervisor, you must also send the same email to the International Admissions Office ([iao@ynu.ac.jp](mailto:iao@ynu.ac.jp)).

#### (2) How to Apply

Enclose all the application documents listed in Section 3 in an envelope. Write "Chinese Government Graduate Student Overseas Study Program" on the envelope and mail the envelope to the address stated in Section 13 by registered mail or any other similar method. At the same time, email (1) Information Sheet, (2) Application form and curriculum vitae and (3) Field of Study and Research Plan to the email address stated in Section 13.

### 5. Application Deadline

Your application documents must reach us no later than Wednesday, January 4, 2017; otherwise, we will not accept your application. Please be sure to submit your documents earlier, fully considering mailing delivery conditions that it takes longer than usual to deliver the mails during the year-end and new-year holiday season.

### 6. Screening Procedures

Short-listed applicants are decided through the screening of application documents. However, applicants may be required to have an interview if necessary. In this case, each graduate school will notify applicants of the interview details.

## **7. Notice of Screening Results**

You will be notified of your results by email on Monday, February 6, 2017. If you pass the screening, we will issue a letter of conditional acceptance and a certificate of exemption to you as a short-listed applicant.

## **8. Decision on Successful Applicants**

The short-listed applicant will be considered as a successful applicant if he/she has passed the Screening for the State Scholarship Fund conducted by the CSC to become a recipient of the scholarship, and has emailed a copy of and posted the original of the Certificates of the State Scholarship Fund (in English and Chinese) to the address stated in Section 13. After receiving a notice of selection from the CSC, you must promptly submit the certificate to us. If you made an application as a prospective master's degree holder, you must also promptly email a copy of and post the original of a certificate of completion of master's degree issued by your university. Even if you are not selected by the CSC, you still need to promptly notify us of the fact.

## **9. Application Fee, Admission Fee, and Tuition Fee**

You do not need to pay an application fee. Successful applicants are exempt from admission and tuition fees. Note that if your academic performance is significantly poor after your admission, you may not be exempt from your tuition fee. If you are not selected by the CSC as a scholarship recipient, and if you still wish to study at Yokohama National University as a self-financed international student, you will need to pass the entrance examination conducted by the graduate schools. If you want to take the entrance examination, please inform us when you notify us of your failure to be selected.

## **10. Admission Procedures**

You will be promptly notified of the admission procedures (including the procedures for obtaining a Japanese visa) after you have been selected as a successful applicant.

## **11. Application Instructions**

- (1) You cannot have your application documents returned for any reason once we accept them.
- (2) You are not allowed to change your graduate school after applying.
- (3) If your application documents are found to contain any false information, your admission may be canceled even after you have been selected as a successful applicant.
- (4) If admitted, you can move into a room for single persons in the university dormitory (Ooka International Residence) that we provide. If you want to live with your family, first come to Japan by yourself; then bring your family to Japan after finding appropriate housing by yourself. In this case, you need to bear all the costs necessary to bring your family to Japan and live with them. You should be aware that it is rather difficult and costly to find family housing.

## **12. National Security-Related Export Controls**

Yokohama National University has instituted its own rules for national security-related export controls based on the Foreign Exchange and Foreign Trade Act and rigorously screens the admission of international students to control the transfer of goods obtained in Japan to other countries, provision of technology, and exchange of personnel. Any international students subject to export control regulations may have restrictions placed on their chosen research activities, or may be ineligible to receive education at the University. Prospective students should therefore

consult their proposed academic advisor before submitting their application, or take other precautionary measures when applying to study at the University.
